# National Forest Timber Sales and Timber Cuts, FY 1980-2018

# Background

This interactive map allows users to view and download data on total timber volume, value, and price sold and cut from National Forests. Data are presented at the National Forest, State, and National Forest Region scale for Fiscal Years 1980 to 2018.

## Why Is It Important?

Timber and forestry jobs remain an important part of the economy in many rural communities throughout the U.S. West and South. As public land management priorities and timber markets change, tracking timber sales, cuts, and price on public lands can be important to understanding local and regional economic dynamics and opportunities.

Timber cuts from public lands also feature in policy and political debates, and good information can inform better decisions. For example, see the bill draft introduced in 2011 in the U.S. House of Representatives (the *National Forest County Revenue, Schools and Jobs Act*) or Headwaters Economics ongoing discussion of potential county payments reform.<sup>i</sup>

The Forest Service makes cut and sold reports available to the public, but only by downloading pdf's published on its website for each Forest Region, making trend and comparative analysis difficult. These interactive maps allow users to track trends and easily compare timber sales, cuts, and prices across geographies. The download option makes data available in Microsoft Excel for more sophisticated analysis.

## **Methods**

Average sold price and average cut price is the quotient of total timber volume sold and cut divided by total timber value sold and cut for each National Forest, State, or Forest Service Region. This is the average price received by the Forest Service for timber sold and cut in each year and may not reflect market value for timber sold and cut from private, state, or other federally managed lands.

## **Additional Resources**

Timber receipts and receipts from other commercial activities on federal lands affect payments to local governments that are made to compensate for the non-taxable status of federal lands. Headwaters Economics also updates interactive maps showing how federal land payments are distributed to counties and states. Maps and data cover historic payments as well as current policy maps which project what happens if SRS is not reauthorized and counties receive only a revenue sharing payment from the Forest Service, and what happens if PILT is reformed into a single payment to counties: <u>https://headwaterseconomics.org/dataviz/county-payments/</u>.
